

**BEFORE THE ARKANSAS STATE BOARD OF DENTAL EXAMINERS**

**IN THE MATTER OF: DONNA D. MASSEY, D.D.S.**

**ORDER**

On this day comes for hearing the matter of Donna D. Massey, D.D.S. The Arkansas State Board of Dental Examiners appeared together by a quorum of its membership, together with its attorney, William H. Trice, III; and Donna D. Massey, D.D.S. appeared *pro se*. From the Pleadings and agreement of the parties, the Board finds that:

**I**

Donna D. Massey, D.D.S. is licensed to practice dentistry in the State of Arkansas under the provisions of the Dental Practice Act.

**II**

The Board issued an Order and Notice of Hearing dated February 17, 1998 charging Donna D. Massey, D.D.S. with permitting Glenna K. Jenkins, R.D.H. to administer local anesthesia injections prior to receiving a permit from the Arkansas State Board of Dental Examiners to do the same; thus, an alleged violation of Arkansas Code Annotated § 17-82-316(c), Arkansas Code Annotated § 17-82-103(c), as well as an alleged violation of Article XVI(c) of the Rules of the Board.

**III**

Pursuant to Arkansas Code Annotated § 25-15-208(b) of the Administrative Procedure Act, the Board and Donna D. Massey, D.D.S. have entered into the following agreement to resolve this matter:

- A) Donna D. Massey, D.D.S. will comply in the future with the Dental Practice Act and the rules and regulations of the Arkansas State Board of Dental Examiners.
- B) Donna D. Massey, D.D.S. will tender to the Board the sum of \$100.00 for the sum of administrative costs and fees in this matter.
- C) The Arkansas State Board of Dental Examiners will dismiss the present charges pending against Donna D. Massey, D.D.S.

WHEREFORE, it is CONSIDERED, ORDERED, and ADJUDGED that the agreement of the parties is a fair and equitable agreement, and is entered into pursuant to Arkansas Code Annotated § 25-15-208(b) of the Administrative Procedure Act. The terms of the agreement of the parties is ordered by this Board and the charges pending against Donna D. Massey, D.D.S. are dismissed.


