

**BEFORE THE ARKANSAS STATE BOARD OF DENTAL EXAMINERS****IN THE MATTER OF: DALE M. REMERSCHIED, D.D.S.****CONSENT ORDER**

On this day comes for hearing the matter of Dale M. Remerscheid, D.D.S. The Arkansas State Board of Dental Examiners appeared together by a quorum of it's membership together with it's attorney William H. Trice, III. Dale M. Remerscheid, D.D.S. appeared *Pro Se*. From the pleadings and evidence introduced and agreement of the parties the Board finds that:

1. Dale M. Remerscheid, D.D.S. is a licensed dentist in the State of Arkansas pursuant to the provisions of the Dental Practice Act.
2. Under provisions of the Administrative Procedure Act, more specifically, Arkansas Code Annotated § 25-15-298(b) the Board has the authority to enter into a Consent Order with any licensee.
3. The parties agree that Dale M. Remerscheid, D.D.S. submitted to the Board proof of completion 42 hours of Continuing Dental Education for the years 1998 and 1999.
4. The a parties agree that 10 of said hours submitted by Dale M. Remerscheid, D.D.S. failed to comply with the Rules and Regulations of the Board more specifically, they did not relate to "the provision of services and patient care" or "contribute to updating and maintaining the knowledge and skills of the dentist or dental hygienist in the treatment of an individual patient".
5. The parties agree that in lieu of any additional sanction or punishment as a result of Dale M. Remerscheid, D.D.S. failing to comply with the 40 hour requirement of Continuing Dental Education of the Board that:
  1. Dale M. Remerscheid, D.D.S. will provide to the Board proof of completion

of 10 additional hours of Continuing Dental Education which will apply only for his 1998 and 1999 time frame. Said proof of completion will be presented to the Board and approved prior to it's regular meeting on January 12, 2001.


- 2. Dale M. Remersheid, D.D.S. will pay to the Board a fine in the amount of \$500.00 within thirty days of the date of this Order.

- 1. The agreement of the parties as stated hereinabove ss a fair and equitable agreement ;and the Board adopts the same as the Boards Order.
