

BEFORE THE ARKANSAS STATE BOARD OF DENTAL EXAMINERS

IN THE MATTER OF: BRYAN C. CHILDRESS, D.D.S.

ORDER

On this 18th day of April 2003 comes on for hearing the matter of Bryan C. Childress, D.D.S. The Arkansas State Board of Dental Examiners appeared together by a quorum of its membership together with its attorney, William H. Trice, III. Bryan C. Childress, D.D.S. appeared pro se.

From the application for licensure of Bryan C. Childress, D.D.S., information provided by Bryan C. Childress, D.D.S. and the agreement of the parties, the Board finds that:

- 1.) Bryan C. Childress, D.D.S. has applied for a license to practice dentistry in the state of Arkansas.
- 2.) Bryan C. Childress, D.D.S. has had his license to practice dentistry in the State of Oklahoma revoked as a result of substance abuse.
- 3.) Pursuant to A.C.A. § 25-15-208 (b), Bryan C. Childress, D.D.S. makes the following offer to the Arkansas State Board of Dental Examiners:
 - (a) That the Board will issue a license to practice dentistry to Bryan C. Childress, D.D.S.
 - (b) That Bryan C. Childress, D.D.S. has entered into a aftercare health contract for drug and alcohol monitoring with the Arkansas Medical Foundation on the 28th of January 2003. A copy of which is attached as Exhibit 1 to this Order.
 - (c) That Bryan C. Childress, D.D.S. will comply with the terms of the Arkansas Medical Foundation contract for a period of five years.
 - (d) That the Arkansas State Board of Dental Examiners may revoke or suspend the license or impose other sanctions on Bryan C. Childress, D.D.S. upon the Board finding that Bryan C. Childress, D.D.S. has violated the terms of the contract of monitoring with the Arkansas Medical Foundation attached as Exhibit 1 or violates any provisions of the Dental Practice Act or the rules and regulations of the Board

for a period of five years.

WHEREFORE it is CONSIDERED, ORDERED, AND ADJUDGED that:

- 1.) The Board finds that the offer of Bryan C. Childress, D.D.S. is a fair and equitable offer and protects the citizens and patients of Arkansas and permits Bryan C. Childress, D.D.S. to practice dentistry in the State of Arkansas.
- 2.) The Board accepts the offer and adopts the provisions of said offer in Paragraph 3 above as the Board's own order.
